INTERNATIONAL STUDENT DECLARATION OF FINANCIAL RESOURCES

Hendrix College requires a Declaration of Financial Resources from each applicant who is not a United States citizen or a holder of a permanent resident (immigrant) visa. The completed form must accompany the Application for Admission, and is required to certify a student's eligibility for the F-1 student visa.

Please note: *Hendrix's total cost (tuition, room, board, and mandatory fees) for the 2010-2011 academic year is \$41,126, and we anticipate a 4-6% increase from year to year. Aside from the one International Student Scholarship the college awards, which covers the cost of tuition (\$31,740 for the 2010-2011 academic year), the maximum assistance Hendrix can offer an international applicant is \$15,000 per year. Therefore, the recipient of the International Student Scholarship must provide at least \$9,400 per year toward his or her Hendrix education. All other international candidates must provide at least \$26,200 per year. This amount does not include personal expenses, which can be an additional \$3,000 to \$4,000. Please consider these limitations before deciding to apply to Hendrix College.*
