Justification:

This proposed major is intended to provide the interdisciplinary tools necessary to understand contemporary issues surrounding the policy, practices, and services of Social Work. Since this field takes on many different dimensions, it is important to have a background and understanding of the many fields that go into Social Work. This major works to bring together the historical practices and policies that gave way to discrimination and inequality, the psychological impact that discrimination has on individuals, the political understanding of public policy and court rulings that shape social aid and intervention, as well as, a cross discipline understanding of the self and issues of identity and inequality.

Although many graduate Social Work programs accept a variety of majors, it is important to me that I complete this interdisciplinary study because I intended to focus primarily on issues pertaining to children and families. In the case of children it is important to understand how issues of identity and discrimination can impact their future so that I can be sure to center my work in a way that combats the negative impact that historical, political, and societal norms have on their chance for future success. This interdisciplinary major would also provide a deeper understanding of how historical practices and policies, current political decisions, and social understandings work together to create issues of injustice. With a deeper understanding, I would be provided a more enhanced view of how to change issues of injustice and provide the best social aid I can to children and families.

To provide the best cross discipline understanding, this major has been divided into four sections: Political Science and Social Justice, Historical and Contemporary Context, Identity and Inequality, and Research Methods. The first section (Political Science and Social Justice) contains courses that provide an in-depth understanding of how the U.S. government has handed issues of inequality and how legislation and court rulings impact groups of individuals differently. The second section (Historical and Contemporary Context) pulls from many different fields to provide me the opportunity to examine ways that Social Work has been applied in the past as well as ways that it can be applied in a contemporary context and the tools necessary to take part in administrative, hands-on, managerial, or organizational positions in the field. The third section (Identity and Inequality) draws from several social sciences to enhance my understanding of identity and its importance when looking at issues of inequality and how the two are related as well as tools to participate in efforts to reduce inequality and discrimination through diversity practices and policies. Lastly, the fourth section (Research Methods) adds an understanding of research methods and statistics in various fields which would be extremely important in a field as broad as Social Work so that I could accurately asses studies that are released or conduct my own in an effort to create or examine practices to reduce discrimination and inequality.

With this major I hope to gain a deeper understanding of the many fields that make up "Social Work." I believe that in completing this interdisciplinary major I will gain the tools necessary to take up whatever position in social services I desire and provide as much of a positive impact as I can in dismantling injustices in America.
