Rationale within departmental and collegiate context and based on assessment results:

Public Health has recently become a subject of great interest among Hendrix students and citizens across the state of Arkansas and the nation. This awareness of the importance of public health was long overdue. Hendrix College has begun to address this interest by the hiring of a faculty member to teach public health courses, and by the implementation of a joint program with the College of Public Health at UAMS to draw more students into this academic arena. We feel that the next logical step in this progression is the implementation of a minor in Public Health. Enrollment patterns and discussion with students inside and

outside the Allied Health program, and even disucssions with prospective students, has shown that interest in this area is both wide and deep.

Due to the diverse backgrounds and career goals of students entering the public health arena, the minor draws on courses from 4 different majors. A background in public health can be useful for students with an equally wide array of career goals include medicne, law, psychology, nursing, public planning, sociology and many others.

In parallel to this major, we will also be planning to offer a public health track within the allied health major, hence the exclusion of students majoring in allied health from taking this minor. *Proposers are welcome to attach additional documentation for more complex proposals, such as the addition of a major or minor.*
