**Visiting Hours**: Sunday: 9:00 a.m. – 6:00 p.m.

**Visiting Procedures:** Visitors must sign in at the dorm of the student they are visiting. They must wear a visitor's badge and remain with the student they are visiting at all times. Visitors may not use campus computers or recreation equipment or facilities. Before departing, visitors must return their visitors' badges to the dorm and sign out. These are important security measures—visitors who violate these policies may cause the student they are visiting to be dismissed from the program.

**Sunday Leave:** Students may sign out of the dormitory and leave the campus on Sundays between 9:00 a.m. and 6:00 p.m. with a parent or a person listed on the "List of Approved Persons Allowed to Check Student Out of AGS" from the student forms previously signed by parents. Additional names may be added after the session begins. However, the AGS office must be notified by **4:00 p.m. on Thursday prior to that Sunday** or the new names cannot be added to the student's list for that weekend. **Email/Fax requests must include a scanned driver's license of the parent or guardian.** 

**Parent's Day and Mid-Session Break:** Parents are invited to attend their child's class at 1:30 p.m. on Tuesday, July 3, prior to checking him/her out for the mid-session break. Students may be checked out between 2:30 p.m. and 5:00 p.m. on that day. Dinner will **NOT** be served that day. **Residence halls will close at 5:00 p.m.** 

AGS reopens on Sunday, July 8. Students should check-in at their residence halls between 6:00 p.m. and 8:00 p.m. on that day. Dinner will **NOT** be served that day.

**Closing Day:** Students will be dismissed from AGS at 10:30 a.m. on the final day, Saturday, July 21. Parents should meet their student at his/her residence hall between 10:30 a.m. and 12:00 p.m. Students will **NOT** be released before 10:30 a.m. Lunch will **NOT** be served that day. **Residence halls will close at 12:00 p.m.** 

#### **Guidelines for Living**

The following rules govern and partly define the AGS community. Please be sure that you fully understand them in letter and spirit.

#### 1. Alcoholic Beverages/Tobacco/Illegal Drugs

Possession or use of alcoholic beverages, tobacco products, or other illegal drugs will result in immediate dismissal. Please note that medical cannabis is prohibited on the grounds of any school; therefore, any student with a valid medical marijuana ID card may not possess or use medical cannabis while on AGS campus.

#### **Visitor Smoking Policy**

Tobacco products are prohibited from use on the Hendrix College campus including parking lots, grounds adjacent to buildings, and athletic fields. AGS students are responsible for the behavior of their guests.

#### 2. Avoiding Fire Safety Hazards and Unsafe Practices

#### A. Policy Statement

• Fireworks, explosives, candles, incense, and items constituting an open flame, burning element hazard, or an unsupervised flammable object hazard are prohibited from campus. Unsafe usage of materials is also prohibited.

B. Materials and items that are acceptable in residence hall rooms unless specifically misused include:

• Electrical cords, connectors, or outlets containing a circuit breaker; hair dryers, and other personal hygiene items. "UL" approval on an item does not guarantee that the item will be allowed in residence hall rooms. Questions about the acceptability of a specific item should be directed to residence hall staff.

• Towels should never be hung over A/C unit vents to dry. Obstructing vents may cause damage to the unit.

#### C. Materials and items that are prohibited from residence hall rooms include:

- Flammable liquids and chemicals;
- Lighted or unlighted candles, incense, and combustible fluid lamps;
- All appliances employing open burning coils, toasters, toaster ovens, and pizza ovens;
- Halogen or quartz light bulbs and lamps requiring such bulbs;
- Extension cords, connectors or outlets that contain multiple outlets, are frayed, or overloaded.
- Extension cords, power strips or extension boxes that are not connected to a surge protector.

#### D. Fire Safety Hazards—prohibited practices include the following:

- Any modification of existing electrical equipment, such as outlets, light fixtures wiring, etc;
- Running electrical cords under carpeting, a door way, or window;
- Connecting high wattage appliances or other electronic equipment to outlets by extension cords that do not contain breaker switches;
- Decorating a student room by hanging tapestries, flags or posters on the ceiling, or in a way that covers vents on appliances or electronic equipment;
- Tampering with fire safety equipment, including smoke detectors, fire extinguishers, or fire alarms;
- Any other practice which constitutes a fire hazard.

#### 3. Bicycles, Unicycles, Hoverboards, Skateboards, Scooters, Roller blades, Skates.

No bicycles, unicycles, hoverboards, skateboards, scooters of any variety, roller blades, or skates are permitted at any time.

#### 4. Bullying and Cyberbullying

At all times, students are expected to treat each other and all AGS personnel with respect and contribute to the wellbeing of the AGS community. All forms of bullying (written, verbal, electronic, physical) will not be tolerated.

#### 5. College Property

Damage to college property will be replaced or repaired at the participant's expense. Window screens must not be removed. Nothing should be tacked or glued to walls or windows. Students may not post notes, announcements, or pictures in private or public spaces without permission from the Director. Furniture in residence rooms must not be moved or altered in any way.

#### 6. Computers/Tablets

Students should not bring personal computers or tablets to AGS. Computers with internet access are provided in the computer lab. Participants must not use AGS computers to a) play or download games, music, movies, or other copyrighted material, b) view or download pornography, or c) engage in any sort of harmful or unauthorized programming.

#### 7. Dress

In general, students should always dress and groom in a manner that:

- is respectful to themselves and the AGS community.
- is not disruptive or distracting to the educational process.
- does not pose a threat to the safety and health of self or others.

AGS generally enforces the following guidelines noting that exceptions may be needed in certain cases (religious requirements, accommodations for disability, etc.).

#### General Campus:

- 1. At all times, a student's midriff, back, lower chest, and upper thigh must be covered. Clothing should not obscure a student's face unless required by religious practices.
- 2. Clothes displaying any language, images, or symbols that are profane, obscene, vulgar, promote drugs or alcohol, or are insensitive to race, sexual orientation, ethnicity, religion, or gender are not allowed.
- 3. Dresses, skirts, and shorts must be of appropriate length to not reveal the upper thigh or buttocks (for most, beyond the length of the student's thumb when the arms are at rest).
  - a. If wearing shorts or a skirt, a student's shirt should not extend past the shorts or skirt.
- 4. Undergarments should never be visible including underwear, boxer shorts, and bras (excluding the strap).
- 5. Leggings are permitted if they are worn with dresses, tunics, oversized shirts, or other acceptable tops as long as the article of clothing on the top is of appropriate length (see guideline #3).
- 6. Sleepwear or loungewear such as pajamas should not be worn outside of the residence halls unless special permission is granted. School-sponsored theme days such as "pajama day" are an exception to this rule.
- 7. Appropriate footwear with soles should be worn at all times.
- 8. Swimwear is not permitted as appropriate clothing except during specified recreational activities or in certain areas such as the pool. Please see additional guidelines below regarding dress in recreational areas.

#### Residence Halls:

- 1. Dress in residence halls is more relaxed than other areas of campus; however, students are still expected to choose attire that is modest and appropriate. The general campus dress code guidelines must be followed in hall lobbies.
- 2. As a general rule, clothing should cover students' lower chests, upper thighs, and buttocks.
- 3. No undergarments should be visible at any time including underwear, boxer shorts, and bras (excluding the strap).
- 4. Students should be clothed when they leave their rooms including short trips to the bathroom or shower. It is not appropriate for students to appear outside of their room or in the bathroom in underwear, a towel, shirtless, or without pants or shorts. Robes or loungewear should be used between the shower and room.
- Sleepwear or loungewear such as pajamas may be worn as long as they adhere to all other residential hall guidelines.
- 6. Shoes are not required although it is recommended that students cover their feet with shoes, sandals, flip-flops, socks, etc.

Recreational Areas (WAC, Pool, Tennis Courts, etc...):

- 1. Appropriate athletic or gym shoes must be worn by all students past the WAC lobby. Street shoes, sandals, flip-flops, or bare feet are not allowed, even for spectators.
- 2. Proper exercise attire must be worn when using the WAC. Non-exercise attire such as jeans will not be allowed in the gym or strength/cardio areas.
- 3. Shirts must be worn at all times excluding the pool.
- 4. Swimwear is allowed at the pool or at water-related recreational activities such as slip and slides. All swimwear should be modest. String bikinis, thongs, speedos, or other suits that are intended to provide minimal covering are not permitted. Students should change into their swimsuits at the pool (locker rooms are available), or if wearing their swimsuits when walking to the pool, students should wear cover-ups over suits or shirts with swim shorts. Towels are not appropriate cover-ups. (*See also WAC and Pool Rules on page 9*)
- 5. Jewelry and other valuables should be left in your residential hall.

#### 8. Fines

The fine for lost room keys is \$50 (It is <u>strongly recommended</u> that students bring a lanyard or keychain for their room keys. Lanyards are available for purchase in the AGS Store). The fine for a lost library book is \$100, and the fine for a lost ID is \$25.

#### 9. Honor

Stealing, lying, or cheating under any circumstances will result in immediate dismissal. Failure to inform AGS staff about others' rule violations, or to cooperate with AGS staff investigating suspected rule violations, will result in immediate dismissal.

#### 10. ID Badges

Official ID badges must be worn at all times, unless instructed otherwise. ID badges are required for admittance into the student's residence hall and the dining hall. There is a \$25.00 charge for lost ID badges. Visit the AGS Office to report a lost ID badge.

#### 11. Mandated Reporting

In accordance with Arkansas Child Maltreatment Act, AGS faculty and staff are required by law to report child maltreatment. Child maltreatment refers to any abuse, sexual abuse, neglect, sexual exploitation, or abandonment of a person under the age of 18. If any faculty or staff member has reasonable cause to suspect that a child has been subject to maltreatment or observes a child being subject to conditions or circumstances that would reasonably result in maltreatment, then a report must be made immediately to the Child Abuse Hotline (1-800-482-5964). Please be aware that any references to child maltreatment in class discussions, assignments, or conversations are subject to mandated reporting under the law.

#### 12. Multi-use Electronic Devices

Students are not allowed to bring multi-functional portable media players and tablets to AGS. These include, but are not limited to: iPad, Surface, Kindle and other devices that include internet functions. A computer lab is available for access to the Internet.

#### 13. Obedience

Students are expected to follow all instructions given to them by any members of the AGS faculty and staff.

#### 14. Online Classes/Projects

At AGS, students are encouraged to dedicate their time and focus to the many academic and social opportunities that will be offered. Furthermore, the academic and social challenges that students will encounter require intense concentration and effort. Therefore, in order to reduce distractions from the AGS curriculum and activities, students are not permitted to enroll in online coursework during the session. Additionally, students are strongly discouraged from participating in non-AGS projects or research that are intensive and may distract from one's AGS experience.

#### **15. Prescription Medications**

Students **must** notify AGS of any prescription medications in their possession and update this information if medications change during the program. Any prescription medications in a student's possession **must** be in his or her name. Prescription medications are not to be transferred between students.

#### 16. Required Presence

Participants must attend all classes and other required activities. Participants must be in their residence halls by 10:30 p.m. each night. Participants must not leave campus except as according to the leave policy (page 7).

#### 17. Telephone Use

No calls - incoming or outgoing - are allowed between 11:30 p.m. and 7:00 a.m. Students may use cell phones only in their residence hall rooms and only during non-class times between 7:00 a.m. and 11:30 p.m. *Students are not permitted to use or carry their phones outside of their rooms unless special permission is granted*. Violations will result in confiscation.

#### Sexual Misconduct

It is the intent of AGS to maintain an environment free from all types of sexual misconduct. No student should be subjected to sexual misconduct by other students or AGS personnel at any time. This policy will be enforced with the utmost seriousness and haste.

#### I. Definition of Sexual Misconduct

- A. Sexual Misconduct any continued, unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct (i.e. comments, jokes, gestures, messages, hugs, tickles, pokes, grabs, etc...) of a sexual nature that has the effect of:
  - 1. Unreasonably interfering with a student's participation in or benefit from the educational atmosphere.
  - 2. Creating a hostile environment by persistent conduct or by a single severe instance.
  - 3. Implying, whether implicitly or explicitly, that a student's presence at AGS or an activity or that program-related decisions related to the student are based upon submission to such conduct.
- B. Types of conduct considered to be forms of sexual misconduct and violate this policy include but are not limited to:
  - a. Sexual violence including rape and sexual assault
  - b. Sexual advances (physical and verbal)
  - c. Comments about inappropriately touching someone
  - d. Lewd or sexually suggestive comments, jokes, innuendoes, or gestures
  - e. Stalking
  - f. Inappropriate social media posts

#### II. Reporting

- A. All AGS students, staff, and faculty are protected from any form of retaliation for reporting potential violations of this policy or participating in any investigations under this policy. Any conduct reasonably considered to be retaliation against someone who submits a report of sexual misconduct or participates in any resulting investigation from a report is strictly prohibited. Such retaliation will be considered as an act of misconduct and will be handled in the same manner in accordance with this policy.
- B. All AGS community members including students, faculty, and staff are encouraged and expected to immediately report any knowledge of sexual misconduct and/or retaliation. This includes anyone who believes he or she is a victim, anyone who is a witness, and anyone who has reliable information about an incidence.
  - i. Students may submit an oral or written report of an alleged violation of this policy to any faculty or staff member including the Director. Any AGS employee who receives a report of an alleged violation must immediately notify the Director. In the case of an oral report, the AGS staff member should take careful notes and confirm that the recorded details are accurate.
  - ii. Reports of alleged sexual misconduct or retaliation violations should be clear and detailed. At a minimum, a report should include:
    - 1. The identity of the alleged victim
    - 2. The identity of the alleged offender
    - 3. The identity of the person submitting the report
    - 4. The identity of any witnesses, if any
    - 5. The date, time, and location of the alleged violation
    - 6. A detailed description of the alleged act in violation of this policy

#### III. Consequences

- A. The Director will form a Behavioral Issues Committee to investigate alleged violations of this policy and determine resulting disciplinary actions, if any. Members of the committee will include the Director, the Coordinator of Residence Life, the Administrative Manager, and two faculty members. In choosing the committee members, the Director will make reasonable considerations to ensure that its membership is diverse with regard to gender and ethnicity.
- B. All reports of alleged violations of this policy will be treated with seriousness and confidentiality. In a timely manner, the Behavioral Issues Committee will investigate all reported incidences of alleged sexual misconduct or retaliation. Members of the Behavioral Issues Committee will be expected to keep all related information confidential and will take reasonable measures to protect the anonymity of an accuser.
- C. Parents or legal guardians of the alleged victim and the alleged offender will be notified that a report of sexual misconduct or retaliation has been made.
- D. The alleged victim and alleged offender will be instructed to avoid any contact or communication immediately following any report of alleged violations to this policy. This action may require administrative changes to the class and residential assignments of the alleged victim or alleged offender. These changes may remain in place regardless of the outcome of the investigation.

- E. When an investigation is completed, the Director will first notify the alleged victim and then the alleged offender of the findings and resulting consequences, if any. Disciplinary action is at the sole discretion of the Behavioral Issues Committee. Any student who is determined to have violated this policy may be subject to disciplinary action, up to and including dismissal from the program.
- IV. Prevention and Enforcement
  - A. The AGS community as a whole has a responsibility to maintain an environment free from sexual misconduct. There are reasonable and practical steps that can be taken to ensure enforcement of this policy as well as help prevent incidences of sexual misconduct.
    - i. All students, faculty, and staff are expected to fully cooperate with any investigations under this policy. All parties included in any investigation under this policy are expected to respect the privacy of the alleged victim and alleged offender and keep related information confidential.
    - ii. Any faculty or staff responsible for discipline of students are expected to enact any disciplinary action(s) decided upon by the Behavioral Issues Committee against any student determined to be in violation of this policy.
    - iii. During faculty and staff orientation, the Director or administrators will instruct all personnel on the sexual misconduct policy and procedures.
    - iv. Within the first two (2) days of students' arrival to AGS, the Director will ensure that all students are instructed on the sexual misconduct policy and procedures.
    - v. The sexual misconduct policy and procedures will be available to all students, parents, and AGS personnel via the student handbook, AGS website, and the AGS Office, which will provide a copy upon request.

#### **AGS Leave Policy**

Arkansas Governor's School is state funded, highly competitive, and interested in fostering a very strong sense of community among its participants. Therefore, it is believed to be inappropriate for students who have accepted a place at AGS to take temporary leaves from the program. Time away from the program has an undesired effect on student participation, both for the individual and for the Governor's School community at large. We know that gifted and talented students will have many quality opportunities during the summer. Although we hope that students invited to attend AGS will accept our invitation to attend for the full six weeks, we understand that other choices are available and difficult decisions must be made. For students desiring to take advantage of other opportunities that coincide with AGS, students should decline the AGS invitation which will allow another student to be invited to benefit from the entire program.

Temporary leaves will be granted for certain situations and only these situations. Requests for special leaves of absence must be made in writing <u>at least one (1) week in advance</u> and include explicit justification for the leave. Documentation may be requested to verify listed justification. A form may be obtained from the AGS office once the session starts. A leave may be granted for the following situations:

- unplanned personal or family emergencies
- weddings of immediate family members
- extremely important events of major personal, regional, or national significance
- medical reasons

Please note:

- proper paperwork must be filled out and submitted at least one week in advance
- the student cannot miss more than 2 class days
- the leave cannot be during the first 3 days or the last 3 days of the program
- no student may be granted more than one leave of absence
- leaves granted for medical reasons may not exceed a total of six (6) class days
- proper documentation may be requested to verify the listed justification for the leave

## AGS Wellness and Athletic Center and Pool Rules

- 1. AGS students must use the pedestrian footbridge when traveling to and from the Wellness and Athletic Center. Students may not cross until after 4:00 p.m. Monday Friday and 1:00 p.m. Saturday Sunday.
- 2. AGS students must return to the main campus by 9:00 p.m. or by closing times on the AGS Facilities Schedule, whichever is earlier. All facilities are closed to AGS during required events.
- 3. AGS students may not linger in parking lots, get into cars, or meet non-AGS people across the footbridge.
- 4. WAC and pool are closed during AGS required events.
- 5. AGS Nametags must be presented for entrance to WAC or pool and for equipment checkout.
- 6. Visitors of AGS students/faculty/staff are not allowed to use WAC or pool facilities.
- 7. AGS students may not go upstairs in the WAC.
- 8. AGS students may not go behind any of the control desks in the WAC.
- 9. Appropriate clothing and footwear must be worn:
  - a. Pool no cut offs, gym shorts, or street clothes allowed in the pool.
  - b. Pool swimsuits must be modest (no string bikinis, thongs, or speedos).
  - c. Pool cover-ups and footwear must be worn to and from the pool.
  - d. WAC gym shoes must be worn by EVERYONE who goes past the lobby; no street shoes, sandals, flip-flops, or bare feet will be allowed even for spectators.
  - e. WAC exercise attire must be worn. Students may not wear blue jeans in the gym or cardio/strength areas.
  - f. WAC shirts must be worn at all times. Colored jerseys are available for team sports.
  - g. Individuals must provide own towel for pool and to wipe down equipment in cardio and strength areas.
- 10. No food/drink/gum allowed in the WAC or pool. Only water in a container with a lid is allowed.
- 11. Individuals are responsible for their belongings. Small lockers are available for use.
- 12. All belongings must be removed when WAC or pool closes. Items left behind will not be accessible until the following day.
- 13. Individuals must comply with all rules and regulations of WAC and pool and obey directions from WAC and pool staff. Disregarding rules can result in loss of privilege and possible expulsion.
- 14. Pool:
  - a. Enter pool area through locker rooms.
  - b. Shower before entering pool.
  - c. Bring own towel.
  - d. If sun screen is used while on the deck, wash off with soap before entering pool.
  - e. No running, dunking, wrestling, or any other type of horseplay.
  - f. No PDA.
  - g. Use equipment (e.g. kickboards, flippers, etc.) properly and put them up after use.
  - h. Do not swim in the diving board areas while others are using the boards.
  - i. Low boards: one bounce only. High boards: one bounce only, no dives, no flips.
  - j. Lanes are for lap swimmers only.
  - k. Be courteous to those working out by not crossing over the lane ropes. Get out and walk around, if necessary.
- 15. WAC Cardio and Strength Areas (Fitness Room):
  - a. Use equipment properly. WAC staff can demonstrate proper use. Improper use can result in loss of privilege and possible expulsion.
  - b. Bring own towel or use cleaning wipes in fitness room and wipe down equipment after every use.
  - c. Re-rack weights when finished.
  - d. Do not linger in this area unless you are waiting on a machine. No more than one person waiting on a machine at a time.
  - e. Be courteous to those working out. Keep noise to a minimum. Don't congregate.
  - f. When lifting weights on the platforms, AGS students must have a spotter standing near them to assist with weightlifting. AGS students CANNOT lift heavy weights by themselves. The WAC Fitness Center employee can help AGS students with spotting and proper weightlifting technique.
- 16. WAC Rock Climbing Wall
  - a. AGS students must be certified by WAC employee in order to belay climbers.
  - b. Don't distract climbers and belayers. Only climbers and belayers may go inside the roped area.
  - c. Athletic, close-toed shoes are required to climb on the rock wall. Socks must be worn with rock wall shoes.
  - d. During certain listed hours, WAC members have priority on the ropes. AGS students may climb during this time unless WAC members are present.
- 17. WAC Outdoor Fields
  - a. AGS students can use the turf field, track, and softball field. An RA or WAC supervisor must accompany you to the softball field and be with you at all times. Sunflower seeds are PROHIBITED on all fields.
  - b. If WAC is closed, AGS students must enter/exit through the pool.
  - c. Take plenty of water to avoid dehydration.

# **Guest Speaker Series - 2018**

#### June 12 - Dr. Jason Wiles (AGS '92)

Jason Wiles is a native Arkansan and AGS alumnus. He earned his first degree in biology (with a minor in Bible) at Harding University and holds graduate degrees in biology, geology, and science education. Dr. Wiles is now a biology professor at Syracuse University.

#### June 14 - Jenna Elser (AGS '03)

Co-founder and artistic director of Glow Lyric Theatre, Jenna Tamisiea is a versatile actress and stage director in both straight and musical theatre, and is Director of the Converse Opera Theatre at Converse College. She has performed and directed with companies across the South and Southeast, including The Arkansas Repertory Theatre.

#### June 21 - Nate Powell (AGS '95)

Nate Powell is the first and only cartoonist to win the National Book Award. Born in Little Rock, Arkansas in 1978, he began self-publishing at age 14 and graduated from School of Visual Arts in 2000.

Powell's work has received a Robert F. Kennedy Book Award, three Eisner Awards, the Michael L. Printz Award, four YALSA Great Graphic Novels For Teens selections, the Walter Dean Myers Award, and is a two-time finalist for the *Los Angeles Times* Book Prize.

#### June 26 - Phil Plait

After earning his doctorate in astronomy at the University of Virginia, he worked on the Hubble Space Telescope as a NASA contractor at the Goddard Space Flight Center. He began a career in public outreach and education with the *Bad Astronomy* website and blog, debunking bad science and popular misconceptions. He hosted the TV show "Phil Plait's Bad Universe" on the Discovery Channel in 2010 and was the head science writer for "Bill Nye Saves the World" on Netflix.

#### June 28- Mark Camp

Mark Camp is the Director of the Keep Arkansas Beautiful Commission (KAB). KAB is a division of the Arkansas Department of Parks and Tourism and a certified state affiliate of Keep America Beautiful. Before joining KAB, he worked as an investment banker for Crews & Associates in Little Rock, Arkansas, where he served as senior vice president.

#### July 10 - Haider Newmani

Haider's powerful and fascinating lectures include poignant and touching visuals from his experience in war-torn Iraq as a citizen of the country and a war journalist. His various capacities as a journalist, a civilian, an activist and a family man have given him a unique perspective about war.

#### July 17- Dr. Joseph Sebarenzi

Dr. Sebarenzi, former head of the Rwanda Parliament, is currently a visiting professor at the School for International Training where he teaches conflict resolution and human rights, a member of the Board of Directors of Karuna Center for Peacebuilding, a regular speaker on BBC and Voice of America, and he also serves as advisor to the Human Rights and Special Prosecutions Section (HRSP) in the United States Department of Justice.

#### July 19 - Maxine Maxwell

Maxine Maxwell is a native of St. Louis and a graduate of Webster University Conservatory of Theatre Arts. As an actor, Ms. Maxwell has toured throughout the country. She has worked in New York as both a solo artist and as a member of performing ensembles.
