- 1. Call to Order (7:00 PM) with Introductions
- 2. Outline of today's (September 18th) meeting.

- 4. Minutes from the last meeting approved.
- 5. Report by the ECC Chair
 - a. Elisa introduced Glen Hook ('91), the Arkansas Sierra Club Director.
 - i. See "Point 9."
- 6. Report by ECC Vice-Chair, Campaigns
 - a. As of Thursday 315 students have taken the Sustainability Fund survey.
 - b. The Sustainability Fund would work through a nominal fee (between \$5 and \$20) charged to students similar to the Student Activity Fee.
 - c. The survey indicated that the majority of respondents favored a \$20 fee (amounting to \$55,000 a year). 92% of respondents were willing to pay some amount of money.
 - d. The Sustainability Fund would be managed via a committee composed of faculty and students who would review proposals seeking funds. It would function like a Campus Committee (i.e., separate from Senate Committees). It would report directly to the President's Office.
 - e. The Sustainability Fund would fund projects promoting sustainability at Hendrix College (e.g., energy audits, retrofits/renovations, etc.). The fund would mainly support capital cost and would leave operations to Facilities.

- j. Report by ECC New Student Representatives
 - i. Nothing to report.
- 9. Presentation given by Glen Hooks.
 - a. Glen Hooks is a Hendrix Alum ('91) who was involved with the ECC. He was waitlisted for law school; during this time he worked on numerous political campaigns. Afterward he attended law school, but decided he was not interested in practicing law. He became director of the state Democratic Party. Today, he is the Director of the Arkansas Sierra Club.
 - The Sierra Club is an environmental protection group founded in 1892 by John Muir. It focuses on clean air and water, forest issues, protecting our national monuments and renewable energy.
 - i. The Arkansas Sierra Club has close to 3000 members.
 - c. If you want to do environmental activism as a career, it is possible!
 - i. The Sierra Club itself offers the Sierra Student Coalition and the Green Corps training program for young environmental activists.
 - d. Glen is interested in supporting student-led initiatives at Hendrix through publicizing events, helping financially, and providing other resources.
 - e. The Arkansas Sierra Club's biggest initiative is the Beyond Coal Campaign, which promotes moving away from coal-powered plants towards alternative energy sources (solar, wind, geothermal, etc.).
 - f. The EPA's proposed Clean Power Plan will have a major impact on Arkansas' energy generating infrastructure. Arkansas contains 19 coal-fired power plants putting out 41 million metric tons of CO2 per year. 85% of these emissions originate from five coal-fired plants.
 - i. Clean Power Plan outlines a reduction of CO2 emissions by 44% in Arkansas. The final plan will be decided on by June, 2015.
 - ii. The shutdown of outdated coal-fired power plants will create an opportunity for alternative energy and creating thousands of jobs.
 - iii. Currently Arkansas purchases \$675M worth of coal from Oklahoma to burn here. Meanwhile, we have companies in Arkansas making wind turbines and solar cells and zero renewable energy being generated.
 - iv. The Sierra Club is collecting public comments to send to the EPA supporting the plan. Likewise, at 10 AM October 1st the Department of Environmental Quality will be holding a discussion on the proposed rules.
