

2021-2022 Verification Worksheet – V5(D)

Your FAFSA was selected by the U.S. Department of Education for a review process called "Verification". We are required by federal law to verify that the data provided on your FAFSA is accurate. If there are any discrepancies between your FAFSA and information provided on this worksheet, we will update your application, recalculate your aid eligibility if needed, and notify you of any changes to your financial aid package.

This worksheet and any additional documentation required should be returned to the Office of Financial Aid within 45 days. <u>All</u> required documentation must be submitted and reviewed before Verification can be completed.

Verification must be completed before your financial aid can be applied to your student account and no later than May first of the 2021-2022 academic year. If Verification is not completed, all academic year federal, state, and need-based Hendrix aid will be canceled.

Section H: Next Steps

1. Schools must verify FAFSA data with information provided directly from the IRS. If you checked that you have filed a 2019 U.S. Income Tax Return you must retrieve your IRS data using one of the following two options: IRS Data Retrieval Tool or providing a signed IRS Tax Return.

Option #1: IRS Data Retrieval Tool

- ✓ Log in at www.FAFSA.gov
- ✓ Click **Make FAFSA Corrections** located in the middle of the page.
- ✓ In the Financial Information section, answer the eligibility questions and click **Link to IRS.**
- ✓ **Proceed to the IRS Site**, enter the requested information, and click submit.
- ✓ Review information retrieved from your tax return and check the **Transfer Now** box on the left hand side of the screen.
- ✓ Click the **Transfer Now** button on the right hand side of the screen.
- ✓ Click the next button until you reach the **Sign and Submit** page.
- ✓ Complete the signing process on the Sign and Submit tax of your FAFSA.

Option #2 Signed Tax Return – If you do not want to use the IRS Data Retrieval Tool or you are not eligible to use the tool, you must provide a signed copy of your 2019 IRS Tax Return

NOTE: If your parents are married and they filed separately on their 2019 U.S. Income Tax Return, they must provide a 2019 IRS Tax Return Transcript for each of their returns in order to complete verification.

- 2. Gather all documents listed in the cover letter and this verification worksheet.
- 3. Submit all documents together at one time via one of the methods listed in the "Submission Instructions".
